- 1. The Kip-Kipp Family Newsletter**

Into the second year of the Kip-Kipp Family Newsletter with Volume 2, Issue 1, 2023. This issue looks at the next in age son of Hendrick Hendricksen Kip and his wife Tryntje Lubberts who were married in Amsterdam, The Netherlands 5 May 1624. Their eldest son Abraham Kip did not appear to have come to New Amsterdam (now New York City). The next five born children (all in Amsterdam, The Netherlands) are in the records of New Amsterdam and their youngest child was baptized in New Amsterdam. There were seven years between the two youngest children so it is known that Hendrick and his family arrived in New Amsterdam after 1638 and before 1643.

- 2. Edward Kipp, HBSc, PhD, MLS**

Edward and I decided to take a trip into Northern Ontario in the summer of 1968 and it was the 20th of June when we headed north with our canoe on top of the car. We were both taking a trip that neither of us had ever gone on before. The plan was to go to Lake of the Woods area between Thunder Bay and the Manitoba border. We had two weeks for our trip as Edward took his first real break from working on his PhD. Our car was still relatively new so taking such a long trip was in the books for sure – nothing to be concerned about and we had a good trip. We stopped and camped along the way and canoed a lot of small rivers we had never been on before. It was great fun and Northern Ontario is everything that anyone could wish for in terms of wonderful camping and canoeing.

As always Edward had plans to go to a few places of interest from a genealogical viewpoint and we achieved all of those goals as well. His maternal grandmother was born in Muskoka and we had headed that way as we went north. Initially he had thought to do a longer trip visiting cousins in Saskatchewan but decided to save that

for another time (and he did visit his Kipp cousins there in the summer of 2000). For the most part none of his Kipp cousins knew more than he did about the Kipp family. It seemed somewhat shrouded in mystery to me looking in from the outside. I continue with that thought except for the revealing created by yDNA testing which linked him with known descendants of the Kip family of New Amsterdam. Very exciting for him and he put a great deal of time into extracting Kip/Kipp descendants from the Census of the United States of America. 4. What do we know about Hendrick Hendricksen Kip (4th son of Hendrick Hendricksen Kip) ?

From Edward's notes ([this information from the History of the Kip Family in America]): Hendrick was baptised in Amsterdam. Holland, Aug. 14, 1633 and he came to America with his parents. He grew to manhood at the homestead on Bridge Street overlooking the East River. Hendrick entered politics before his marriage. He was admitted to the rights of a Great Burgher in New Amsterdam, April 17, 1657, and about this time removed to New Amstel (now New Castle) on the Delaware River where he soon became one of the Council. He engaged in the brewing trade. He was Schepen in 1659. On Sept. 9, 1659 he was a member of the Council of New Amstel. On June 29, 1660, he was appointed one of the Commissaries there. When the English took possession in 1664, he moved to Midwout (Flatbush), Long Island.

He was chosen Overseer of that Town on April 3, 1665, and held the office also in 1666, and until April 1667. He was Churchmaster from 1667 to 1670, and was appointed Inspector, Feb. 25, 1670. He died late 1670 or early 1671. He was referred to as the Captain.

Hendrick, baptized 14 August 1633 in the Oude Kerk in Amsterdam. DTB 006p376
Sponsors are Giertje Jans and Aeltje Vogels, both unknown.

One can certainly understand what inspired Frederic Ellsworth Kip to write the history of his family. His line was reported incorrectly several times in publications.

HENDRICK HENDRICKSEN KIP, JR.

CHAPTER IV

No. 4

Hendrick Hendricksen Kip², Jr. was bap. in Amsterdam, Holland, Aug. 14, 1633, and was therefore a child when he came to this country with his parents Hendrick Hendricksen Kip, Jr. in 1637, and grew to manhood in their homestead 1633-1670 on Bridge Street overlooking the East River.

On Feb. 29, 1660, he married a reigning belle of New Amsterdam, Anna de Sille, the accomplished and brilliant daughter of Nicasius de Sille, First Counselor to Director General Stuyvesant, and next to him the most important man in New Netherland at that time.

The De Sille family belonged to the Court circles of Holland, and their arrival was an event in the society of those early times.

Nicasius de Sille brought over a quantity of silver plate and entertained lavishly, giving many fashionable parties and dinners, and as he was a widower for several years after he came to New Amsterdam, his young daughter, Anna, then in her fourteenth year, must have learned the duties of hostess at an early age.* We read that Governor Stuyvesant's family, Mrs. Bayard, the La Montaignes and the Kips were his most frequent visitors, and Hendrick Kip wooed and won the fair daughter of the Counselor.

Hendrick Kip, Jr. entered politics before his marriage.

He was admitted to the rights of a Great Burgher in New Amsterdam, April 17, 1657, and about that time removed to New Amstel (now New Castle) on the Delaware River where he soon became one of the Council.

New Amstel was situated in the Colony of New Sweden which had been captured by the Dutch in 1655.

The total population was barely 500 souls so New Sweden had been obliged to surrender when Gov. Stuyvesant with a force of seven warships and seven hundred soldiers sailed into Delaware Bay and up the river, and won a victory without loss of a single man on either side, Sept. 10, 1655.

Nicasius de Sille superintended the preparation of the fleet and accompanied the Governor on this successful expedition.

In 1656 a number of Dutch families removed there from Manhattan and other places on the North River, and seventy-five deeds of land were granted then, mostly for lots in the town of New Amstel. This was the founding of the beautiful town, later New Castle, Delaware.

In 1657 New Amstel was governed by a "Vroedschap," or permanent council of seven members, elected by the burghers, and from this body three magistrates were chosen, who, with a Schout and Secretary, constituted a court for the administration of justice. Lots were conceded to the colonists, a magazine was erected, the fort was repaired, and a guard house, together with a residence for the clergyman and other public offices were built. Soon they erected a town hall, a log house two stories high and twenty feet square. All of the public buildings were enclosed

3. Contributions to the History of the Kip Family of New York and New Jersey, by Edwin R. Purple, 1877.

There is an error in this book as Hendrick Kip, Jr is recorded on page 16 of this as a descendant of his brother and was not listed on page 10 as a son of Hendrick the emigrant. It was noted however that this Hendrick was the First Counsellor to Director General Stuyvesant in this book.

This book, page 2, is incorrect. The wife of Hendrick Hendricksen Kip (emigrant as an adult) was Tryntje Lubberts and they married 5 May 1624 in Amsterdam, The Netherlands. This Hendrick Hendricksen Kip married to Tryntje did not return to The Netherlands and leave his young children in New Amsterdam.

5. **First Three Generations of Hendrick Hendricksen Kip Junior**

1-Hendrick Hendricksen Kip [13], son of Hendrick Hendricksen Kip [1] and Tryntje Lubberts [2], was born in Aug 1633 in Amsterdam, Noord-Holland, Netherlands, was christened on Aug 14, 1633 in Amsterdam, Noord-Holland, Netherlands, and died in 1670 in Flatbush, Long Island, NY at age 37.

Hendrick married Anna De Sille [220] [MRIN: 67], daughter of Nicasius De Sille [227] and Cornelia Meulmans [228], on Feb 29, 1660 in New Amsterdam, New Netherland. Anna was born on Nov 6, 1640 in Maestricht, Netherlands and died on May 20, 1711 in Flatbush, Long Island at age 70. They had five children: Cornelia, Catharina, Hendrick, Nicasius and Petrus.

2-Cornelia Kip [222] was born in Jun 1661 in New York, USA and was christened on Jun 12, 1661 in New York, USA.

General Notes: She was baptized in the Dutch Church at New York. She was received into the Dutch Church of Flatbush, Long Island, on confession of Faith, June 28, 1685, by certificate from Middleborg.

Cornelia married Matthyas (Tys) Pietersen Luyster [230] [MRIN: 71], son of Pieter Cornelise Luyster [232] and Aeltje Tyssen [233], about 1682. Matthyas was born about 1655 in Netherlands and died in 1697 in New York, USA about age 42. They had two children: Peter Tys and Johanna Annetje.

3-Peter Tys Luyster [231] was born about 1683 in Flatbush, Long Island, NY.

General Notes: He was a resident of Flatbush, and was constable there 1724, 1725.

Peter married Anne Barkeloo [234] [MRIN: 73] on May 23, 1719 in Flatbush, Long Island, NY. They had nine children: Cornelia, Margaret, Matthias, John, Ann, Peter, Cornelius, Maria and Willemetje.

3-Johanna Annetje Luyster [10400] was born in 1679 in Monmouth Co., NJ and died circa 1732 in Monmouth Co., NJ about age 53.

General Notes: Sources:

Johanna married Benjamin Holsaert [10401] [MRIN: 3553], son of Johannes Holsaert [10402] and Johanna Havens [10403], circa 1710 in New Utrecht, Kings Co., LI. Benjamin was born circa 1675 in Sluys, Flanders, Netherlands and died circa May 1733 in Marlborough, Monmouth Co., NJ about age 58. They had three children: Cornelia, Thomas Hulse and Richard.

2-Catharina Kip [223] was born in Oct 1664 in New York, USA, was christened on Nov 9, 1664 in New York, USA, and died in 1711 at age 47.

General Notes: She was received into the Flatbush Church, March 30, 1682.

Hendrick married Williamkee Kipp [278] [MRIN: 90]. Williamkee was born about 1665.

2-Nicasius Kip [225] was born in 1666 in Flatbush, Long Island, NY, was christened in 1666 in Flatbush, Long Island, NY, USA, and died on Oct 10, 1713 in Pollifly, Hackensack, NJ, USA at age 47.

General Notes: Boyhood spent in New York where he learned the Coopers trade. He was an extensive landowner at Pollifly, New Jersey. He was active in Town and Church affairs and held several official positions. Married Bergen Co. New Jersey, with certificate from Hackensack, by R. Van Giesen. Both he and his wife were admitted to membership in the Hackensack Church September 22, 1694. The Dutch Reformed Church of Hackensack, elected him Deacon April 16, 1695 and again May 4, 1699. In each instance he served two years. In 1705, for 150 pds he bought of Garret Lydekker, a tract of land at Pollifly where he lived the rest of his life. He built a house about 1686 which survived until 1910-12 when it burned.

Nicasius married Antie Breyant [266] [MRIN: 87], daughter of Pieter Cornelisse Breyandt [267] and Hendriecktje Van Schaick [268], on Dec 20, 1691 in Bergen Co., NJ. Antie was born in Sep 1671 in New York, NY, was christened on Sep 10, 1671 in New York, NY, and died on Jul 31, 1715 in Pollifly, Bergen Co., NJ at age 43. They had eight children: Hendrick, Pieter, Isaac, Cornelius, Jacob, Annatje, Catarina and Elizabeth.

3-Hendrick Kip [270] was born in 1693 in Pollifly, Hackensack, NJ, USA, was christened in Hackensack, Bergen Co., NJ, USA, and died on Mar 10, 1778 in Pollifly, NJ, USA at age 85.

General Notes: Hendrick settled at Pollifly and became owner of the Southern half of his father's farm, containing 220 acres. Hendrick and wife were admitted to the Hackensack Church, April 2, 1715.

Vrouwtie Verwey [371], on Jul 24, 1714 in Hackensack, Bergen Co., NJ. Geertruy was born about 1697 in

Hackensack, Bergen Co., NJ and died on Oct 22, 1776 about age 79. They had six children: Annetje, Vrouwtie, Elizabeth, Nicasie, Henderickye and Garret.

3-Pieter Kip [271] was born about 1695 in Hackensack, Bergen Co., NJ, was christened in Hackensack, Bergen Co., NJ, and died on May 26, 1787 in Pollifly, Bergen Co., NJ, USA about age 92.

General Notes: Pieter and Elsie joined the Hackensack Church April 1, 1721.

I have submitted a request to see if there is sufficient sample to run a Y-700 sample on Edward's kit. If there is, I will request the test at the next sale. He has tested at many sites and particularly Living DNA was able to take his line back to R-Z326. However, the Y-700 provides more information. Edward tested to R-L48 at FT DNA and the path to R-Z326 is as follows: R-L48 to R-Z9 to R-Z331 at which point the choice between R-Z330 and R-FGC49702 and his line is R-Z330 which takes him to R-Z326 which does still appear to be the furthestest down the chart that he can be taken at this time (there are 444 people at FT DNA who have tested for this Branch (32 from Germany, 15 from England, 8 from France, 7 from Switzerland, 5 from Scotland, 5 (only known ancestry the United States of America), 4 from The Netherlands, 4 from the United Kingdom, 3 from Belgium, 2 from Slovenia, 2 from Norway, 2 from Poland, 2 from Austria, 2 from Luxembourg, 2 from Sweden, 2 from Spain, 2 from Puerto Rico, 1 from Kazakhstan, 1 from Canada, 1 Native

American, 1 from Northern Ireland, 1 from Lithuania, 1 from Finland, 1 from Hungary, 1 from Ireland, 1 from Barbados, 1 from Denmark, 1 from Belarus. An interesting group and separating out Germanic countries (Germany, Switzerland, The Netherlands, Belgium, Austria, Luxembourg, Denmark) for a total of 50 of the 444 participants with only 110 of the participants giving a location yields 45.5% Germanic but only in this modern time (actual locations like France, Scotland, other parts of Europe, Scandinavia would certainly be interesting to know the travels of the individuals tested back into the time frame when R-Z326 arose. Doing Y-700 would simply put into the record the results for this Kipp line.

Looking at autosomal matches, Edward has a number of small 8 cM to 14 cM matches with descendants of Hendrick Hendricksen Kip via his son Hendrick Hendricksen Kip at Ancestry. Since he has also tested his autosomal DNA at FT DNA, My Heritage, 23 and Me, and Living DNA I would need to check into those databases as well. I would need to do a longer check on these results to see how many (more than half a dozen roughly but not sure how many, plus I have not been keeping up his chart so would need to do that). I will try to expand the DNA section in the next newsletter. I found these to be most interesting because this Kip family was in New Jersey and Edward's line was in NorthEast Town, Dutchess County at least from 1790 on when he is found on the census next to or living with Jonathan Mead (Isaac Kipp married Hannah Mead according to the Kipp family Bible 29 Aug 1790 but the location is not stated anywhere thus far). Fifty four years of looking in various repositories in New York State and elsewhere did not reveal this marriage which was a disappointment to Edward although he always felt that at least he had been able to collect all the information available to him during the time he searched and would leave it for others to solve this mystery. Given that Edward's families all headed to Canada (primarily as settlers) over 200 years ago the separation factor is interesting plus his maternal line was in the Massachusetts Bay Colony and Rhode Island Colony (Block Island) with some in New York at a later date. The chances of other line matches is always there but it is rather interesting to see these small matches occurring.
